Vice President Report -

Sinkhole Repair

8/20 – One sinkhole was repaired by Long's Excavating
8/25 – Another sinkhole has gotten larger. Dave Zulick and I built a fence around it 10/19 – Put up "Keep Out" signs at sinkhole

LED Lights

8/25 – We uninstalled loaned LED light located at 31 Truman Street and installed new LED light with less wattage and a more yellow glow. We installed a 65 wattage LED light at 45 Hickory Street. Input from residents indicates the light in front of 31 Truman is more acceptable. 10/19 – We have inventory of 3 globes, 3 bulbs, 1 sensors and 3 fixtures for existing lights.

Common Grounds

9/14 – Greenskeeper trimmed weeds on steep hill located at 75 Pin Oak Street

9/22 – Greenskeeper applied fall application of weed killer to common area

10/10 – A tree fell on a townhouse located at 79 Pin Oak Street. Richard Long Tree Co. removed 6 tall pine trees to prevent future problems

10/13 – The homeowner at 75 Pin Oak Street communicated there are several dead trees very close to his home and would like them removed. It was decided to proceed with the removal.

Next three months

- Some grass cutting in common area

- Replace street lights as they go bad

Balances: Current balance in the checking is \$4,216.37; Money Market has \$17,716.55 and there is \$21,648.65 in the CD.

The Treasurer passed out the projected budget for 2016, which was then discussed. It is assumed there will be increases in electric, common grounds due to sinkholes/tree removal, and lighting expenses.

ACC Report -
